Teach program: "2016 saw the massive undertaking of moving our gym from North Queene Anne where it's been the last 5yrs to a new building in SODO. This move was forced by our previous landlord unfortunately not giving us any option to renew our lease but this new building has some exciting potential for growth." - Tyson Cecka, Executive Director. In 2016, we certified 3 out of 5 new coaches in the Apprenticeship program. Certification consists of a rigorous, 12 week program that includes classroom instruction, reading and homework, and hands-on teaching experience. All qualified applicants received a complete scholarship for this \$3000 program. We focused our outreach programs in 2016 to those with the most impact. We ran year-round sessions at PKV for patients and family of those in cancer treatment at the Fred Hutch Cancer Research Center. We used parkour to teach film theory to students from The Overlake School. We continued a program to give free unlimited memberships to K-12 teachers, police, fire, and military personnel, giving out 30 memberships in total. In total, our teaching program reached 2,978 new students and attendance across all programs reached 24,897.

"Build program: ""Throughout 2016 we laid a strong foundation for expanding our parks design program. We worked on a large number of potential projects that didn't come to fruition but gave us important experience along the way."" - Colin MacDonald, Design. Parkour Visions continued work with Seattle architecture firm GGLO to design a parkour area for the renovation of Rhodes Park in Boise, ID. Enthusiam grew for the project so much that the city of Boise ended up near doubling the budget to include safety surfacing over a large portion of the park. When construction is completed in 2017, the Rhodes Park project will be the second (and by far the largest) dedicated parkour park in the US. We continued to publish free videos and resources on the construction and design of sturdy parkour obstacles and our online community STURDYmade. It's become the largest resource of its kind and an invaluable source of information for gym owners and backyard builders alike. www.facebook.com/groups/sturdymade"

Share program: "Thanks to the amazing PKV community of students and volunteers we managed to move our 10,000 sq ft gym (and clear the new space of 15 tons of debris) in about 2 weeks through sheer volunteer power. Thanks so much to everyone who helped out!" - Eric Jusino, Operations. We teamed up with the Sport Parkour League and the Friends of Waterfront Park to hold the first outdoor qualifier competition event for the North Amercian Parkour Championship. Afterwards, we again ran our annual event the PKV Classic: Three days of games, jamming, and parkour in the Seattle sunshine!
